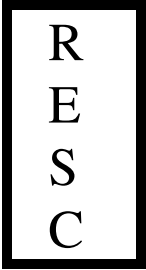

RUMPKE; AN AWESOME COMPANY

Ms. Pratt's presentation will include facts about the Rumpke organization and the firm's early beginnings 75 years ago. Detailed information will be given about modern landfill construction including Federal Subtitle D regulations and the associated specifications requiring protective landfill liners both under and above garbage placed in landfills.

Discussed will be landfill gas extraction and Rumpke's partnership with Montauk Energy Capital and Duke Energy Corporation to operate the world's largest landfill gas-to-direct pipeline energy facility. A visual description of the process will be presented to better illustrate the information covered.

It will conclude with facts about recycling and its necessity and information about the future expansion of Rumpke Sanitary Landfill. (continued on page 2)

DIRECTIONS Proceed on I-275, to Exit 33 (Ohio RT. 27, Colerain Ave.) from the East or West. Exit and proceed North on Colerain Ave. ½ mile to Struble Road. Turn right off Colerain Ave. on to Struble Road. Proceed East one block and turn left through the Rumpke gate. Immediately inside the gate turn right into the parking lot.

There will be a bus in the parking lot for the 45 minute tour.
